



Booking Terms and Conditions

- A non-refundable 50% deposit of the total tariff is required within 14 days to confirm booking.
- Deposits for all bookings made before January 1st, will be required by 15 January 2022.
- Balance of payment is due 7 days before arrival via M/Card, V/Card, Direct Debit or eftpos.
- An administration fee of \$50 per person will be charged on all amendments with a maximum of \$100 per room.
- Cancellations made inside of six weeks prior to arrival will forfeit the 50% deposit with the remainder will be credited against your booking I.D.
- Cancellations made 6 days before arrival and No Shows will be charged the full amount of stay.
- If the cancellation is made outside of six weeks of your arrival date and there will be a \$100 per room administration fee. The balance will be refunded excluding the 50% deposit
- Any and all damages to rooms **will** be charged to the guest.
- A minimum two-night stay is required when booking with Ski Rider Hotel
- All rooms are non-smoking. A fine of \$500 cleaning fee will apply
- All keys are to be returned back to reception upon departure. Any lost or not returned keys will incur fee of \$50 per key
- Any and all credits received from Ski Rider Hotel may only be used on existing, or future bookings with Ski Rider Hotel. All credits are valid for two years from received date.
- All rates are per person based on the capacity of that room, and include breakfast and dinner daily.

Note: Ski Rider Hotel will not be held responsible for costs, loss of deposits, payments made or other fees incurred due to cancellations resulting from unforeseen circumstances, medical conditions or changes to travel plans. Please obtain Travel Insurance if you are concerned.

Should you need to cancel your booking for 2022 as a result of a government directive, contracting COVID-19, or having flu like symptoms, the following options will apply:

- Transfer your booking to a later date in the 2022 season, no amendment fee will be charged. This will be subject to availability and applicable rates will apply.
- Your original booking will be cancelled and the credit will be held against your booking I.D. until you decide on new dates.
- If the cancellation is made outside of six weeks of your arrival date and there will be a \$100 per room administration fee. The balance will be refunded excluding the 50% deposit
- Cancellations made inside of six weeks prior to arrival will forfeit the 50% deposit with the remainder will be credited against your booking I.D.
